

Peer X-Press Terms of Use

Effective Date: May 25, 2018

Introduction

These Terms of Use apply to AIP Publishing's manuscript submission and peer review system, Peer X-Press (PXP), and the affiliated journal sites that link to these Terms (collectively, the "Site"). This Site is owned and operated by AIP Publishing on behalf of itself and its publishing partners and third-party licensors.

Please read these Terms of Use carefully, because by using the Site you are agreeing to these Terms in full. If you disagree with any part of these Terms, please do not use the Site.

Your use of the Site is also subject to the terms of AIP Publishing's [Privacy Policy](#), which is incorporated into these Terms of Use by reference. Please be sure to refer to the Website-specific terms within the Privacy Policy that apply to Peer X-Press.

Purpose and Scope
